



GOING PLACES SWEEPSTAKES!



Official Rules

1. No purchase necessary to enter or claim prize.

2. Prizes: To be awarded as prizes to winners: Grand Prize: A 4 day Cruise for two with a maximum value of \$2,000.00 First Prize: \$750.00 Travel Voucher. Second Prize: \$500.00 Travel Voucher. PLUS drawings for GPS Systems, Gift Cards & More. Promotion begins June 1, 2009 at 12:01 AM EDT and ends midnight July 31, 2009 EDT.

3. How to win: Entries will be made as follows: One entry will be automatically created for each participating credit union member for each transaction completed at a Florida Outlet or Service Center or entry form completed at your credit union from June 1, 2009 through July 31, 2009. No reproductions of Entry Forms will be permitted. Entries become the property of the Florida Credit Union Shared Services, Inc. and will not be returned. By participating, member agrees to abide by and be bound by these Official Rules and to accept the decisions of FCUSS as final.

4. Drawing: Prizes will be drawn by random selection for all qualified entries within 30 days of the conclusion of the promotion. Each drawing will be from entries (transactions and entry forms) received and posted between June beginning at 12:01 a.m. EDT on the first day of the month and ending at 12:00 midnight EDT in July on the last day of the month. All entries during the promotional period are eligible for the prizes. Grand Prize, First Place and Second Place drawings will be held after the conclusion of the promotion. Other drawings will be held periodically during the promotion period. There is no limit on your number of entries. Odds of winning will be determined by the number of eligible entries received during the contest period from credit unions participating in the promotion. Drawings will be by random selection at the FCUSS Network Central Office.

5. Eligibility: To be eligible to participate in the sweepstakes, you must be a member of a Florida Credit Union participating in the Florida Network. Transactions must be completed at a Florida Network Outlet or Service Center. No purchase is necessary to enter the Going Places Sweepstakes. Entrants must be at least 18 years old by May 31, 2009 to win a prize. Credit union employees and their immediate family members, members of the Board of Directors and their immediate families, members employed by FCUSS and their immediate families, members employed by the Florida Credit Union League and their immediate families and individuals living in the households of each of these individuals are not eligible to participate.

6. Winner Notification: Winners will be notified via certified or overnight mail and will be required to complete, sign, and return an Affidavit of Eligibility and Liability Release and a Publicity Release within 14 days after issuance of prize notification or prize will be forfeited. If prize notification is returned as non-deliverable, prize will be forfeited. Prizes must be delivered by November 30, 2009 or they will be forfeited.
